## **City Finances**

## **City Updates**

Enforcement of City Ordinances is being stepped up, primarily focused on late and delinquent water bills. Ordinance 17-01 appends late fees if bills are not paid within 61 days; water bills going forward now have the previous month's bill if unpaid within one month, after which late fees are appended. Several City residents are receiving water shutoff notices due to late payments. Community Services Consortium advised the City that the period to apply for utility bill payment assistance does not begin until October 1 (and only for certain demographics). However, residents with emergency needs, including to pay bills at risk for temporary termination of service, may request assistance from CSC at any time.

The City audit continued September 13 with a visit to City Hall by Koontz & Blasquez staff to examine financial records.

# 11.a. Legislative Letter

## **Staff Summary**

Several small cities in Linn County are collaborating on drafting a joint letter to the League of Oregon Cities regarding the recent legislative proposal survey. Potential signatories include Brownsville, Halsey, Harrisburg, Scio, and Sodaville. Cities are expressing disapproval of the limited membership on policy committees apportioned to small cities (approximately 17%, despite comprising 70% of cities in Oregon), as well as the resulting list of proposals that primarily do not affect small cities. Sodaville's contribution is to format the "ask" of the letter to seek clarification about the selection process for policy committee members, a neutral proposition, along with requests for changes to the process to mandate increased apportionment on policy committees for small cities and establishment of a small city issues committee.

The letter will be signed by the Mayors of each city. A copy of the most recent draft is included in the packet. It is recommended that the Council authorize the Mayor to sign a letter to the LOC regarding the legislative proposal process.

**Suggested Motion:** I move to authorize the Mayor to sign a joint letter to the League of Oregon Cities regarding the legislative proposal process.

# 11.b. City Water

## **Ongoing Water Efforts**

City staff are still in the process of procuring a pump test necessary to verify whether the so-called "Jackman Well" is viable during summer. Once a test has been completed, the Council will make a formal decision on moving forward with renewing the IFA loan on hold.

The South Valley/Mid-Coast Regional Solutions is convening this month to meet with representatives from Sodaville and Waterloo to begin studying the feasibility of an InterTie between these two cities.

During the City/County Insurance Services conference, the City Recorder broached the subject of broader regional water collaboration with other cities in Linn County. There is interest in creating a larger water district that serves several cities in the area given common difficulties providing water experienced by local communities. A water district could take on a Sodaville-Waterloo InterTie along with water projects in other areas incorporated into the District, with each community signing a memorandum of understanding that keeps the District focused on communities served. A larger district serving more communities presents more opportunities for procuring funding from outside sources for water projects.
